

Aspen Pumps Group Interclima promotion 2019; promoting JAVAC tools, VETO bags and Advanced Engineering products

The Promotional Period: Opens on the first day of the show 5th November at 9.00am and closes at 18.00pm on the 8th November. Late entries outside of these times will not be valid.

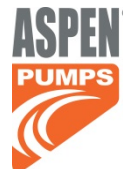
Participants may enter by:
